# Innovating to achieve a competitive edge

# Propelling Victorian manufacturing into the future

Creating a sustainable future for the Australian manufacturing industries and their supply chains is crucial for the nation's future development, particularly as the sector currently faces new and upcoming challenges. With intense competition between developed and emerging nations to create opportunities to innovate, build highly-skilled workforces and improve standards of living, the ways in which Australian manufacturers respond to these challenges will determine the size and shape of the sector.

In global terms, manufacturing is undergoing a transformational shift that will reshape the drivers of economic growth, wealth creation, national prosperity and national security. Bruce Grey, Managing Director of the Advanced Manufacturing Cooperative Research Centre (AMCRC), says that, 'to understand the implications of this we need to ask, 'What is manufacturing?'. Prior to 2000, manufacturing generally referred solely to the production of goods and was characterized by imagery of workers in overalls, lathes, drills, stamping presses, oily machinery and labour intensive factories. By contrast, the post-industrial manufacturing of today is about ideas, products, processes and services. It represents a complex and highly integrated value chain encompassing cuttingedge science and technology, innovation, skills, design, systems engineering, supply chain excellence and a wide range of intelligent services.

AMCRC's focus on innovation is also evidenced by its backing for a revolutionary new technology known as, Additive Manufacturing. Described as a 'third industrial revolution', Additive Manufacturing says Mr Grey,

Propelling Victorian manufacturing into the future

'is essentially the marriage of the computer with manufacturing where a computational model instructs a laser or printer to melt material - such as titanium powder or plastic - to a detailed design.' With these technologies (selective laser melting, electron beam melting, 3D printing and fused deposition modeling) just entering the Australian market Mr Grey says there are marketdriven opportunities for the development of new products and processes that can be made more economically and in flexible production runs. 'The AMCRC will be assisting the development of specialist knowledge of Additive Manufacturing and a wide range of general technology and engineering expertise,' he says.


Similarly, in partnering with SMEs such as Micronisers and CAP-XX, the AMCRC is backing the development of cutting edge intellectual property and providing expert training in how to innovate.

Based in Dandenong, Micronisers is a specialist in the field of nano particles – that is, material smaller than 100 nanometres. At just a billionth of a metre a nanometer is mind-bogglingly tiny. With the support of the AMCRC, Micronisers is working with Monash University

on two ground breaking projects. The first is an examination of nanoparticles in sunscreens. The second involves nucleating agents and polymers. 'For Micronisers,' says Mr Grey, 'the partnership model with AMCRC enables the company to access world class research such as that being undertaken at Monash, but without the costs that they might otherwise incur.'

At high tech manufacturer CAP-XX, finding solutions to extend the life of batteries has led to the development of their high power supercapacitors. The AMCRC has helped enable CAP-XX to access capital and research expertise and provided a very commercial focus for the company. Despite its small size, CAP-XX's impressive track record in innovation has seen it reach global markets through licencing agreements with established manufacturers in Asia. 'In sharing the risk with innovators like CAP-XX, we demonstrate our commitment to supporting technology development for commercialisation,' says Mr Grey.

As a leading producer of knowledge with some of the world's best research institutes, world class education institutions and a legal community well versed in international intellectual property law, Victoria is ideally placed to exploit the new manufacturing



technologies and rapidly growing consumer markets to build an innovation mindset for its SMEs.

For Victorian businesses, a new funding strategy will drive the use of cutting-edge technologies, enabling them to compete in today's global economy. Forming part of the Coalition Government's \$150 million Technology Plan for the Future, an \$8 million Technology Voucher program aims to ensure the state's innovative companies have timely access to the technology expertise they need at critical points of product development. By providing vouchers to organisations in the technology sector, the program will support the development of new products and processes using industrial biotechnology, small technology (micro and nano-scale) or information and communication technology. Vouchers are available

in three categories: Technology Student Accelerator (up to \$10,000 in value); Technology Development (up to \$50,000 in value) and Technology Implementation (up to \$250,000 in value). John is currently Chair of two Company Director Nexus groups, Innovation and Business Skills Australia Ltd Chairman, Austbrokers Countrywide Financial Services Group Pty Ltd, a board member of Carroll and Richardson Pty Ltd, The Innovation Xchange Ltd and the Management Department Advisory Board, Monash University. He is also a member of the Minimum Wages Panel

of Fair Work Australia. He was awarded an Order of Australia Medal in 2001 for his contribution to Science and Engineering and a Centenary of Federation Medal in 2002.

#### Why did you decide to take part in Nexus and how long have you been participating in the program for?

I was interested in joining a group of fellow directors to share ideas and insights to develop my skills as a board member. I have been involved in the Nexus Group since 2010.

## Being part of a Director Nexus Group has enabled you to?

Have a forum to share experiences with colleague board directors.

Gain a greater understanding of the way in which a board can influence innovation within an enterprise.

## In your opinion, What are the most prominent qualities Zoe brings to the Nexus experience?

Her experience as a global executive and her insights that she brings to the discussions within the group.

#### What is your favourite part of the Nexus experience?

Discussing an issue that a group member is grappling with in their board and then learning of the way in which the ideas raised in the discussion has been progressed by the group member in their board.

It has caused me to reflect on the way in which I approach issues at a board meeting.

educational, biotechnology, regulatory, and community organisations. She is currently a Director of PrimeSafe, and a Director and Deputy Chair of Dairy Food Safety Victoria. She is also an active member of both Finance, Risk and Audit Committees and a Science and Technology Committee.

#### Why did you decide to take part in Nexus and how long have you been participating in the program for?

I left my executive role as a global innovation manager to commence a career as a professional non-executive director in 2011. As I had completed the Australian Institute of Company Directors course in 2002 I thought it would be good to expand my networks and meet with like-minded individuals. I enrolled firstly in 2011 and felt the benefits were so great that I again enrolled in 2012.

### Being part of a Director Nexus Group has enabled you to?

Discuss and analyse issues in the news and their implications for directors and boards. Bring relevant issues I am experiencing with the boards I am on and receive suggestions for issue resolution or opportunity exploitation from 6 to 8 of my peers, including recommendations for contacts and consultants,

In particular John has organised for the female members of our group to meet with two highly-experienced female board directors, in order to understand the issues they have faced in establishing their careers, and share how they overcame any obstacles and how they gained success. John has also met with each Nexus Group member individually and made suggestions on how we can improve our capabilities and expand our networks and select boards to target for recruitment which utilise our skills and experience.

## In your opinion, what are the most prominent qualities John Vines brings to the Nexus Experience?

John has brought sound and thoughtful governance to our discussions, and has been an exemplary Chairman in his chairing of our Nexus meetings. He has a wealth of knowledge and experience which he has shared freely.

## MELINDA CILENTO GAICD

In your own words, describe to a member what your role as a councilor for the Victorian Division of Company Directors entails:

I use my listed company and not for profit board experience to guide the strategies, activities and policies of the Victorian Division of Company Directors to best meet the needs of our members and to enhance the reputation of company directors more broadly.

How would you describe the impact on your board in light of recent high profile cases (such as Centro, James Hardie etc.)?

Cases such as these are of course carefully reviewed and discussed by the board with consideration given to potential implications for board policies and practices. But in my view the impact of these specific cases on the boards I sit on has been relatively limited.

In 2013, the biggest issues boards will come up against are:

Some of the big issues for boards and companies in the year ahead include ongoing economic uncertainty and volatility, effective capital management, and the management of skills and key talent. In Australia the year ahead sees a federal election looming large, so political uncertainty and the risks that entails in terms of tax and regulatory changes will no doubt be widely discussed.

Looking back on your board career, what's been a memorable challenge you've faced and how have you overcome it?

On reflection, perhaps the biggest challenge for me was making the transition from senior executive to NED in an industry that was new to me. Retaining a strategic focus when faced with so much new and often technical information was not always easy. My approach was to focus my contributions on those areas where I could clearly add value straight off, and to ask questions in and out of the board room. One of the most interesting challenges I have been involved with as a board director has been the appointment of a new CEO. I certainly feel like I learned a lot through that process.

And finally in your opinion, what are the top three traits all good directors share?

I've been very fortunate to work with some great directors. In my view they have all been diligent, constructive in their approach, and independent thinkers. ®

## Healthcare Forum 2012

This year's Healthcare Forum was on 'Directors making reform a reality', hosted by Company Directors in September at the RACV Club in Melbourne.

Greg D'Arville FAICD, opened the forum and introduced international keynote speaker, Fred Lee, the award winning author of, 'If Disney ran your hospital – 9 ½ things you would do differently.'

It shows how hospitals can emulate the strategies that earn Disney the trust and loyalty of not only their



fans, but also staff who are proud of their association with the brand.

Other guest speakers also brought similarly refreshing ideas to the forum. Shane Solomon, Chairman, Independent Hospital Pricing Authority (IHPA) spoke of the processes and rationale behind the decisions made by the IHPA on pricing reforms. He went into details on how Activity Based Funding 'ABF' impacted public, private and aged care facilities' ability to provide increased and improved services

to the community. The question was raised of whether proposed benefits, including improved transparency, strengthened incentives for efficiency, improved measurement of efficiencies and increased provision of services would ever become a reality?

With health reform firmly on the agenda, Dr Michael Smith, Clinical Director of Australian Commission on Safety and Quality Healthcare (ACSQH), discussed how the new national standards will aim to improve the quality
